Community Center Open Access starts January 8, 2018

The Community Center at Heron River will be open to members for use from 9 a.m. to 10 p.m. on a daily basis starting on Monday, January 8, 2018. Members who have signed the Assumption of Risk and Release of Liability form with revised rules will have their key cards activated for the Community Center doors.

The Board of Directors has reviewed and revised the rules of use for the Community Center and its adjacent facilities including the Pool Enclosure, the Gym, the Tennis Courts, and Children's Play Area (collectively called the HOA Facilities).

The Board of Directors made this change for several reasons.

- 1) The original intent for the facilities was to be open for general use by all HOA members.
- 2) The access was restricted after the building was damaged by some HOA members a number of years ago. Use was limited to official HOA functions and Private Events.
- 3) The Heron River marketing materials, sales website, and real estate agents all state that the facilities are open for use by all members. Homeowners have expressed their displeasure with the old policy restricting access.
- 4) Most importantly, the costs of having our management company manage the Community Center's usage would be prohibitive and volunteer time cannot adequately cover that Private Event usage.

The Board hopes to purchase other items in the coming years to add to the Community Center such as a big screen television, piano, and possibly another pool table depending upon demand. Members can also use the Community Center for playing cards, reading, playing games and other activities.

The HOA has installed Ring security cameras with both video and audio monitoring in the Community Center as well as in other parts of the HOA Facilities. The security recordings are stored in the Cloud and any suspicious activity or rule violations will be subject to review by the Board as necessary or if any damage occurs.

Alcohol will also not be allowable on the premise because of minors and the increase of liability associated with alcoholic beverages.

The Board believes that this policy will provide the promised benefits to all Heron River residents. Private Events can be more effectively handled by local area hotels, banquet halls, country and golf clubs, historic locations, local wineries and other commercial venues.

Chili Cook-Off Results

City's Rezoning Decision Ruled Invalid What Does It Mean?

Six homeowners in Heron River filed the lawsuit called a "Petition for Judicial Review" against the City Council and its June 2017 rezoning decision regarding Crystal Springs Apartments. Attorney Andrea Carroll made oral arguments Dec 5th on behalf of the Petitioners.

Ada County 4th District Judge Moody ruled that the Star City Council failed to make audio records and therefore could not provide legally required transcriptions of two key city council meetings related to rezoning decision.

Therefore, Judge Moody vacated the Council's decision with her ruling on December 13, 2017 which means the rezoning was nullified.

The City Council could allow the developer to make a new application for rezoning of the farmland east of Heron River for a 200+ unit apartment complex.

These homeowners along with dozens of concerned citizens across Star were alarmed that this high density development would result in a dramatic increase of vehicle traffic through Heron River because no traffic light can be installed at Moyle & Hwy 44.

Residents are encouraged to attend City Council meetings and communicate with the Council regarding new applications to rezone.
